Narrative of Officer Paz

On 04/28/2023 at approximately 1714 hours, I, Officer Paz, was dispatched to an Animal call at 7237 SE 27th St, Mercer Island. Dispatch advised that Mercer Island Fire Department (MIFD) was requesting PD for a patient who was attacked by a dog. Dispatch advised that the patient speaks Mandarin.

I arrived on scene and observed the male patient on a stretcher inside of MIFD Aid truck. I contacted one of the Mercer Island firefighters who stated the male patient was bitten by two dogs and only speaks Mandarin. The MI firefighter stated the patient's name is LingHui Wang 12/9/45. I went inside of the MIFD Aid truck and observed bite marks on Wang's right and left thigh. Wang also had a bite mark on his left upper arm. MI firefighter stated that Wang will need stitched on his left upper arm from the bite mark and will be transported to OMH. I took a picture of Wang's injuries with my patrol phone.

After speaking with MIFD I contacted Yee Yin Lee 04/23/72, who stated she lives nearby, speaks Mandarin, and had been translating for MIFD. Lee stated that Wang said he went to the store to buy some chicken to cook for his wife who recently came home from the hospital. Wang was walking back home from the grocery store. Wang was walking westbound on SE 27th St and when he approached the intersection of SE 27th St and 74th Ave SE, two big dogs jumped on him. The dogs caused him to fall on the ground, which

caused scratches to his left palm and center back. Wang tried to kick the dogs off and was bit multiple times.

After speaking with Lee, I contacted Tracy L Sigmon 8/31/70, who stated she witnessed the incident. Sigmon was standing in front of the house at 7249 SE 27th St and observed Wang walking by her. Sigmon stated that she observed two big dogs down the gravel road on 74th Ave SE. The two dogs suddenly ran towards Wang and began barking at him. The two dogs then jumped on Wang, which caused him to fall on the ground. The dogs then bit Wang multiple times. Sigmon stated the dog sitter of the two dogs then grabbed the dogs off Wang.

After speaking with Sigmon, I contacted the dog sitter, Margaret Sue Lloyd 3/30/61. Lloyd stated the two dogs she was watching belonged to her sister, Deborah Lloyd Bertlin 3/23/64, who is out of town until 4/30/23. Lloyd stated she spoke to Bertlin, and she told Lloyd she would take care of everything. Lloyd stated the dogs are a cross between a Great Pyrenees and a Bernese Mountain Dog. Lloyd had the two dogs off leash on her property (2723 74th Ave SE) which is a block away from Bertlin. Lloyd stated that something caught the dog's attention, and they ran down her driveway. Lloyd chased after the dogs and when she caught up to them, she observed the dogs on top of Wang who was on the ground kicking the dogs. Lloyd stated that she did not see the dogs bite Wang. Lloyd stated she would keep the dogs inside of Bertlin's residence until she comes back home. I informed Lloyd that I would forward the report to King County Animal Services, who will contact her and Bertlin.

I provided Lloyd with my business card and case number.

I called Bertlin and left a voicemail. I did not receive a callback from Bertlin.

I printed the pictures I took and placed them in MIPD Records.

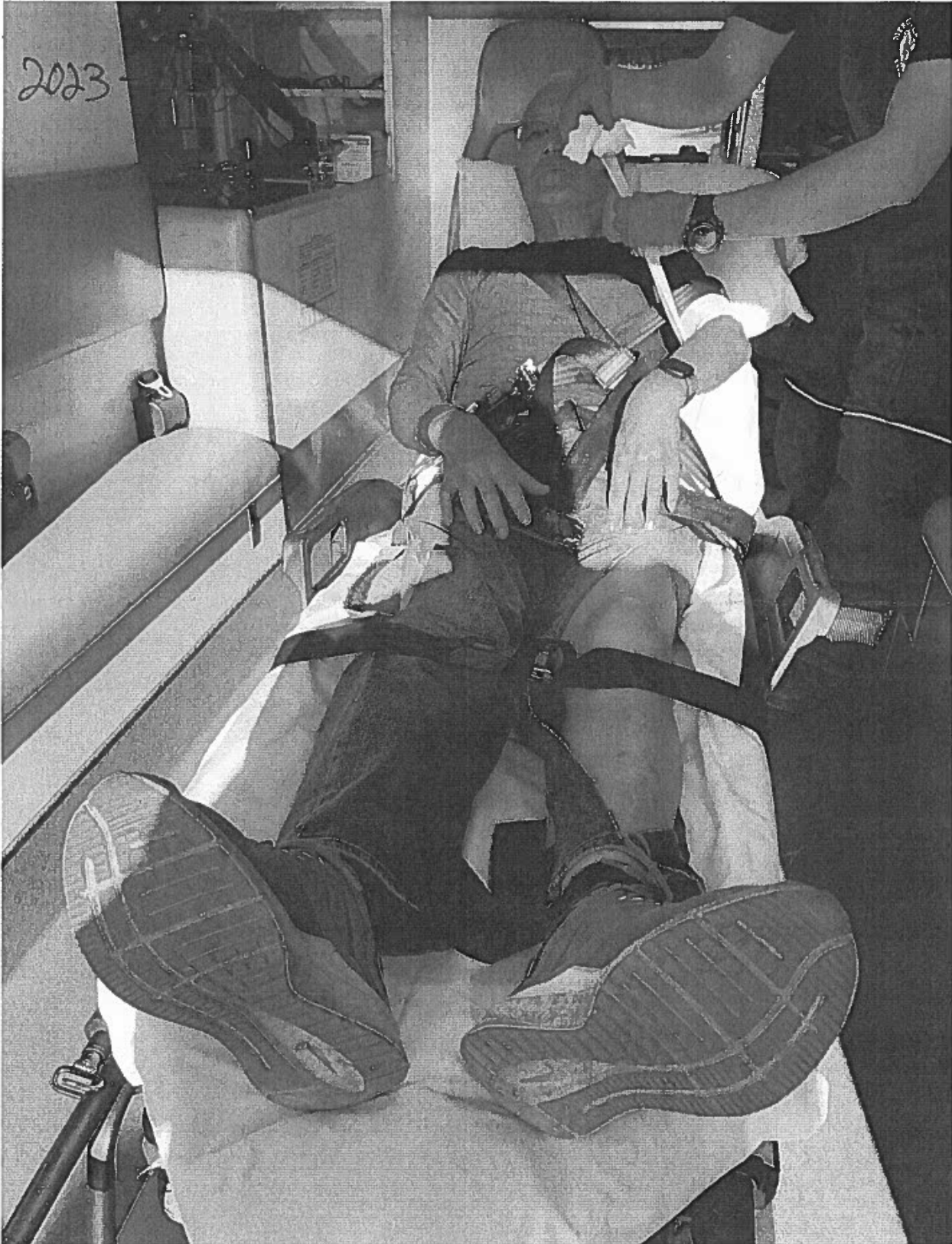

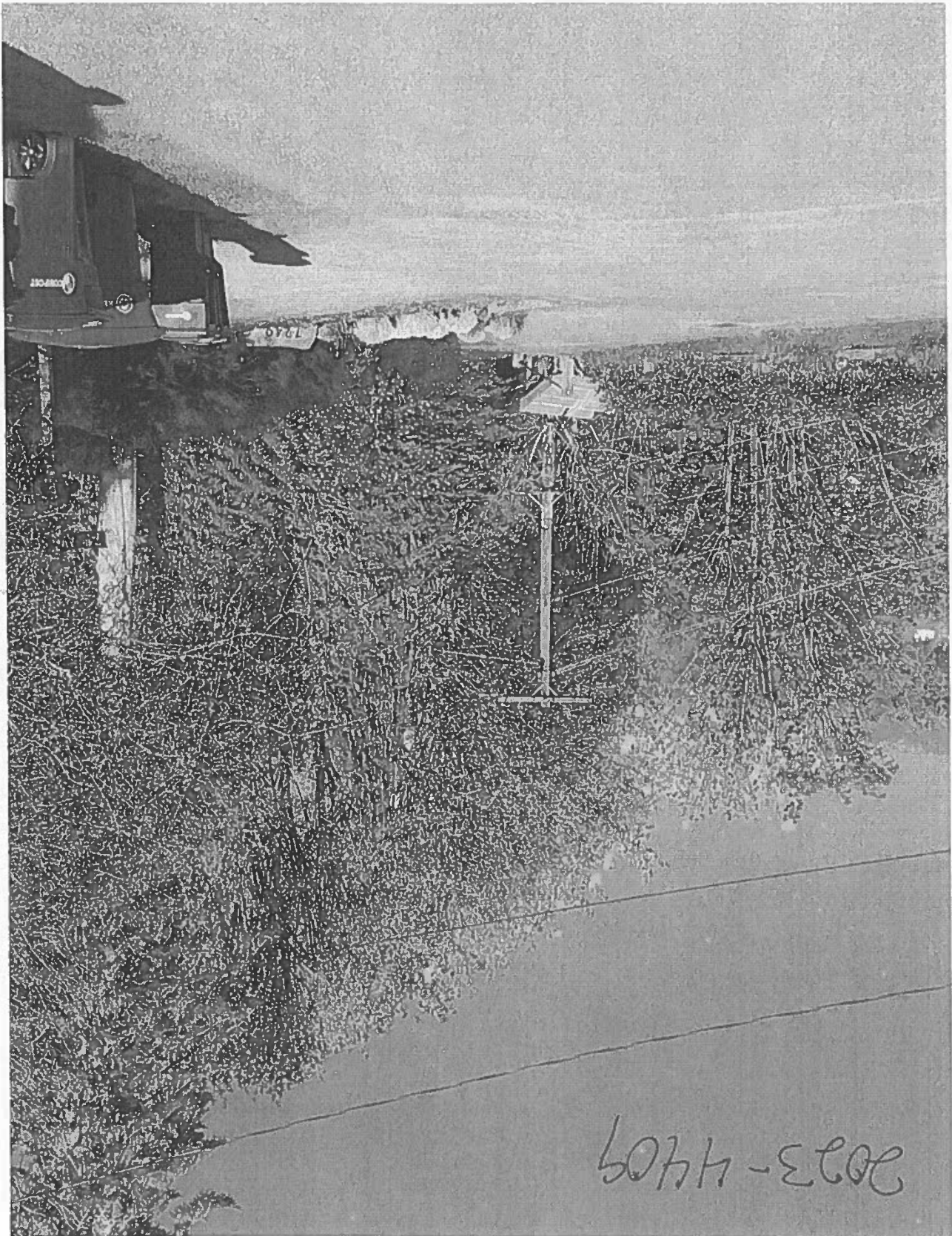
