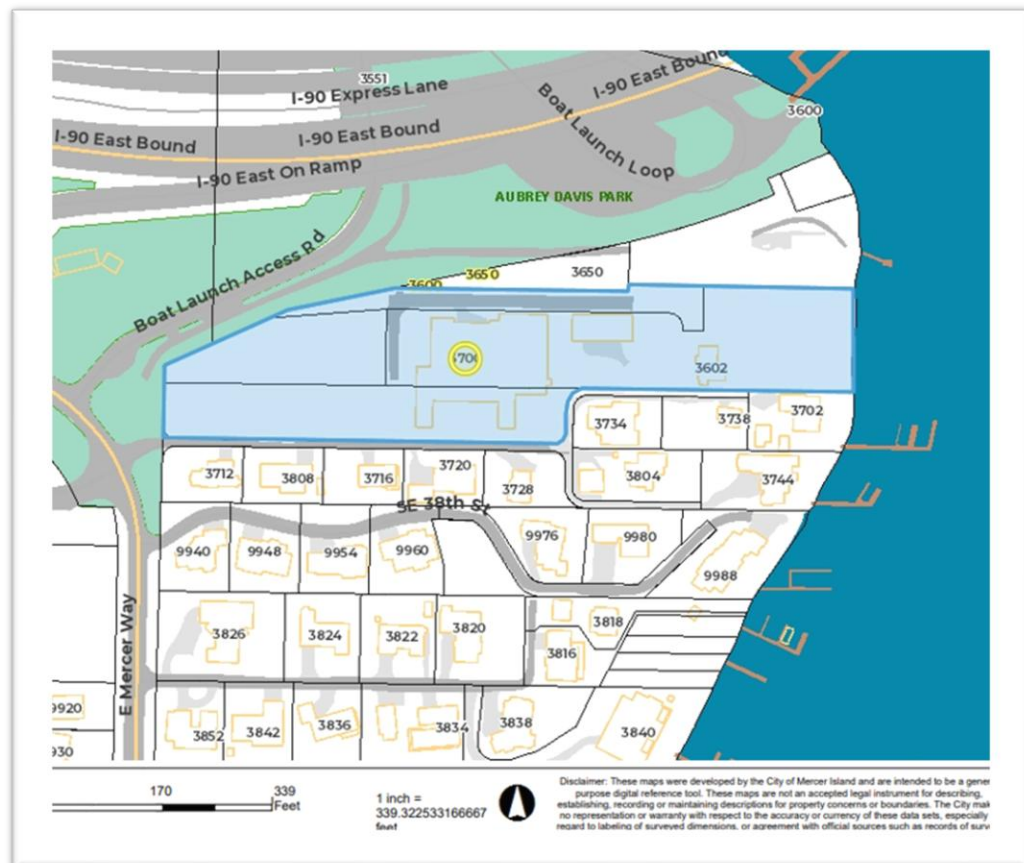

Pursuant to MICC 19.15.030 Table D, a public hearing is required for Design Commission Design Review applications. On June 17, 2025 the City Council passed Ordinance No. 25C-14, which delegated all Design Commission authority to the Hearing Examiner, effective June 30, 2025.

The public hearing for DSR25-009 is scheduled for **October 31, 2025 at 9:00AM**. The open record public hearings will be held virtually using Zoom by either calling in or logging onto the meeting as a Zoom attendee.
