NOTICE IS HEREBY GIVEN for the application described below:

Permit Type: Type IV

Description of Request: A request for a Shoreline Variance Permit for the reconfiguration of an existing public access pier. A Shoreline Variance Permit is requested to vary the proposed pile diameter requirements in MICC 19.13.050(H)(7) to allow the first set of piles at the proposed central and south docks to be greater than 10 inches in diameter and the remaining piles to be greater than 12 inches in diameter.

Only those persons who submit written comments or participate at the public hearing (if a hearing is required) will be parties of record; and only parties of record will have the right to appeal.

Public Hearing and Public Meeting: Pursuant to [MICC 19.15.030](#) Tables A and B, a public hearing is required for Type IV permits. Notice of the public hearing will be provided at least 30 days prior to the hearing date, pursuant to MICC 19.15.100.

Applicable Development Regulations: Applications for Shoreline Variance Permits are required to be processed as Type IV land use reviews pursuant to Mercer Island City Code (MICC) 19.15.030. Processing requirements for Type IV land use reviews are further detailed in MICC 19.15.030.
