We are the owners of the following described real property:

That portion of government lot 4, section 19, township 24 north, range 5 east, W.M., in King County, Washington, described as follows:

Commencing at the intersection of the easterly line of east Mercer Way with the south line of the north 100 feet of the south 500 feet of said government lot 4; thence north 89°27'00" east along said south line 354.00 feet to the true point of beginning; thence continuing north 89°27'00" east along said south line 189.5 feet; thence north 0°33'00" west 27.00 feet; thence north 4°26'22" east 63.24 feet; thence north 89°27'00" east 53.00 feet; thence south 0°33'00" east 10.00 feet; thence north 89°27'00" east to the shore line of Lake Washington; thence northerly along said shore line 10 feet, more or less, to the south line of the north 10 feet of said south 500 feet of government lot 4; thence south 89°27'00" west along said north line to a point which is north 89°27'00" east distant 253.00 feet and north 0°33'00" west 90.00 feet respectively from the true point of beginning; thence north 0°33'00" west from the true point of beginning; thence north 0°33'00" west 5.00 feet; thence south 89°27'00" west 253.00 feet; thence south 0°33'00" east 95.00 feet to the true point of beginning.

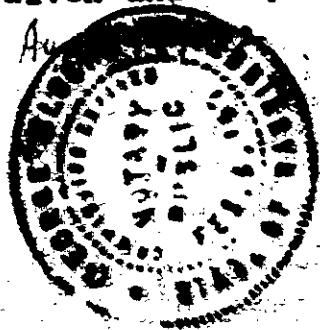
