## SHORELINE EXEMPTION

---

**NOTICE IS HEREBY GIVEN** that approval has been granted for the application described below:

**File No.:** SHL25-038

**Permit Type:** Type I

**Description of Request:** A request for a Shoreline Exemption for the repair of 10 existing piles by sleeving and the removal of two existing personal watercraft (PWC) lifts. The repair would restore the dock to a state comparable to its original condition, including size, shape, configuration, and location. The repair would also include the installation of additional stringers and the replacement of 100 percent of the decking with grated decking with at least 40 percent light transmittance.

**Location of Property:** 9206 SE 33rd Pl, Mercer Island WA 98040  
King County Assessor tax parcel number: 143930-0310

**Zoning Designation:** Residential (R-8.4)

**Shoreline Environment Designation:** Urban Residential. The proposed development is located within the shoreline environment associated with Lake Washington. Pursuant to WAC 173-20-370, Lake Washington is a shoreline of statewide significance.

**SEPA Compliance:** The proposed development is exempt from SEPA Review per WAC 197-11-800(3).

**Exemption:** The proposed development is exempt from the requirement of a Substantial Development Permit pursuant to the provisions of WAC 173-27-040(2)(b) - Normal maintenance or repair of existing structures or developments, including damage by accident, fire or elements. "Normal maintenance" includes those usual acts to prevent a decline, lapse, or cessation from a lawfully established condition. "Normal repair" means to restore a development to a state comparable to its original condition, including but not limited to its size, shape, configuration, location and external appearance, within a reasonable period after decay or partial

destruction, except where repair causes substantial adverse effects to shoreline resource or environment. Replacement of a structure or development may be authorized as repair where such replacement is the common method of repair for the type of structure or development and the replacement structure or development is comparable to the original structure or development including but not limited to its size, shape, configuration, location and external appearance and the replacement does not cause substantial adverse effects to shoreline resources or environment.

**Applicable Development Regulations:**

Applications for Shoreline Exemption permits are required to be processed as Type I land use reviews pursuant to Mercer Island City Code (MICC) 19.15.030. Processing requirements for Type I land use reviews are further detailed in MICC 19.15.030.

To reverse, modify or remand a decision, the appeal hearing body must find that there has been substantial error; the proceedings were materially affected by irregularities in procedure; the decision was unsupported by material and substantial evidence in view of the entire record; or the decision is in conflict with the City's applicable decision criteria.
